Dear Mr. Greenewald:

This letter responds to your Mandatory Declassification Review (MDR) request dated 13 March 2024, received by the Office of the Director of National Intelligence (ODNI). Pursuant to Section 3.5 of Executive Order (E.O.) 13526, you requested declassification review of "the classified annex/ classified report of the potential links between the Wuhan Institute of Virology and the Origin of the COVID-19 Pandemic report submitted to Congress on or around June 23, 2023."

ODNI conducted a search for responsive records and located one document responsive to this request. The document may be declassified in part, with portions currently and properly classified under E.O.13526, Sections:

- 1.4(c), which protects intelligence activities (including covert action), intelligence sources or methods, or cryptology,
- 1.4(d) which protects foreign relations or foreign activities of the US, including confidential sources, and
- 1.4(e), which protects scientific, technological, or economic matters relating to national security, including defense against transnational terrorism.

Additionally, certain portions marked on the attached were withheld pursuant to E.O. 13526, Section 6.2(d), which applies to information exempt from disclosure by statute. Specifically:

50 U.S.C. § 3024(i), the National Security Act of 1947, as amended, which protect intelligence sources and methods.

If you are not satisfied with ODNI's response to your request, you may administratively appeal this decision by submitting a written request to the Chief, Information Management Office, Office of the Director of National Intelligence, Washington, DC 20511 or ODNI FOIA@odni.gov. The appeal correspondence should be clearly marked "Mandatory Declassification Review Request Appeal" and must be postmarked or electronically transmitted within 60 days of the date of this letter. 
